



South Central Telehealth Resource Center - Oct. 2018

Description

An Act To Amend Section 83-9-351, Mississippi Code Of 1972, To Provide That Health Insurance Companies And Employee Benefit Plans May Limit Telemedicine Coverage To Health Care Providers In Network With The Plan Instead Of In A Telemedicine Network Approved By The Plan; To Amend Section 83-9-353, Mississippi Code Of 1972, To Revise The Definition Of "Store-And-Forward Telemedicine Services" For The Purposes Of Coverage And Reimbursement For Those Services; To Revise The Criteria For Qualifying Patients For Remote Patient Monitoring Services; To Delete The Requirement That A Remote Patient Monitoring Prior Authorization Request Be Submitted To Request Telemonitoring Services; To Revise The Provision That Prohibits Placing Geographical Restrictions On The Delivery Of Telemdicine Services To Delete Reference To Services In The Home Setting; To Provide That Health Insurance Companies And Employee Benefit Plans May Limit Telemedicine Coverage To Health Care Providers In Network With The Plan Instead Of In A Telemedicine Network Approved By The Plan; To Prohibit A Health Insurance Or Employee Benefit Plan From Conditioning Payment For Services To A Health Care Provider Or Facility Based Upon The Actions Or Omissions Of Another Health Care Provider Or Facility; And For Related Purposes.

Bill Summary: Provides that health insurance companies and employee benefit plans may limit telemedicine coverage to health care providers in network with the plan instead of in a telemedicine network approved by the plan; revises the definition of store and forward telemedicine services for the purposes of coverage and reimbursement for those services; revises the criteria for qualifying patients for remote patient monitoring services.

Opioid Crisis Intervention Act; create.

Description

An Act To Be Known As The Opioid Crisis Intervention Act; To Amend Section 41-29-149.1, Mississippi Code Of 1972, To Expand The Types Of Drug Violations For Which A Person May Not Be Prosecuted When Complying With The Mississippi Medical Emergency Good Samaritan Act; To Amend Section 41-127-1, Mississippi Code Of 1972, To Provide That Telemedicine Providers Shall Be Allowed To Provide Treatment For Substance Use Disorders, Including Medication-Assisted Treatment; To Direct The State Board Of Medical Licensure To Adopt Reasonable Regulations That Allow Primary Care Physicians To Provide Maintenance Therapy For Persons With Identified Substance Use Disorders And Allow Those Physicians To Provide That Treatment Until The Person Can Receive Treatment From A Licensed Treatment Provider; To Authorize Municipalities, Counties And Public Or Private Educational Institutions To Adopt A Pre-Arrest Diversion Program In Which Law Enforcement Officers Of The Entity May Divert Adults Who Commit A Nonviolent Misdemeanor Offense; To Provide That Adults Who Are Diverted Shall Be Provided Appropriate Assessment, Intervention, Education And Behavioral Health Care Services; To Provide That If The Adult Does Not Participate In The Pre-Arrest Diversion Program, The Law Enforcement Agency May Criminally Charge The Adult For The Original Offense And Refer The Case To The Appropriate Prosecuting Agency To Determine If Prosecution Is Appropriate; To Provide That If The Adult Successfully Completes The Program, An Arrest Record Shall Not Be Associated With The Offense; To Amend Section 9-23-13, Mississippi Code Of 1972, To Require Drug Courts To Allow Medication-Assisted Treatment For Participants When Medically Appropriate; To Bring Forward Sections 41-29-137, 41-29-319, 41-29-321, 73-9-13, 73-21-127 And 73-43-11 Mississippi Code Of 1972, For The Purpose Of Possible Amendment; And For Related Purposes.
